A Bill for an Act to authorise the issue from the Consolidated Revenue Fund of the Federation the total sum of **=N=4,493,363,957,158** (Four Trillion, Four Hundred and Ninety-Three Billion, Three Hundred and Sixty Three Million, Nine Hundred and Fifty Seven Thousand, One Hundred and Fifty Eight Naira) only, of which, **=N=375,616,000,000** (Three Hundred and Seventy-Five Billion, Six Hundred and Sixteen Million Naira) only is for Statutory Transfers, **=N=953,620,000,000** (Nine Hundred and Fifty-Three Billion, Six Hundred and Twenty Million Naira) only is for Debt Service, **=N=2,607,132,491,708** (Two Trillion, Six Hundred and Seven Billion, One Hundred and Thirty-Two Million, Four Hundred and Ninety-One Thousand, Seven Hundred and Eight Naira) only is for Recurrent (Non-Debt) Expenditure while the sum of **=N=556,995,465,449** (Five Hundred and Fifty-Six Billion, Nine Hundred and Ninety-Five Million, Four Hundred and Sixty-Five Thousand, Four Hundred and Forty-Nine Naira) inclusive of **=N=144,420,000,000** (One Hundred and Forty Four Billion, Four Hundred and Twenty Million Naira) Capital Expenditure in Statutory Transfers, is for contribution to the Development Fund for Capital Expenditure for the year ending on the 31st day of December, 2015.

BE IT ENACTED by the National Assembly of the Federal Republic of Nigeria as follows: -
